These high deductible plans pay the same benefits as Plans F and J after one has paid a calendar year [\$1790] deductible. Benefits from high deductible plans F and J will not begin until out-of-pocket expenses exceed [\$1790]. Out-of-pocket expenses for this deductible are expenses that would ordinarily be paid by the policy. These expenses include the Medicare deductibles for Part A and Part B, but do not include the plan's separate foreign travel emergency deductible.
